
Review Report to Members of the Company

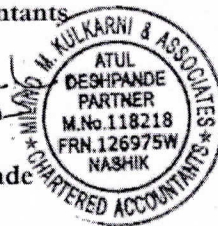

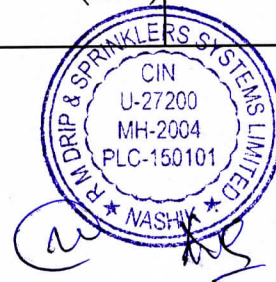
